Deadline for Candidates Form 4's is **March 23, 2019** for names to be listed in the Program Book. All Form 4's must be received by **March 30, 2019**.

Deadline for Banquet Reservations is **March 30, 2019**. Late Reservations will be seated at tables in the order of receipt of the reservation.

Special Meal requests (if necessary for Medical Reasons or Vegetarians) for Candidates, Sir Knights, Ladies and Guests must be shown on the Banquet Reservation Form.

Special Reminder: A Candidate must be a 3rd Degree Member in good standing to be eligible for the 4th Degree Exemplification, and must show a current travel card at the exemplification.

Faithful Navigators are also asked to ensure that all Assembly Members and Candidates are made aware that **PROPER ATTIRE MUST BE WORN** to the Exemplification.

A candidate may wear either a black, dark blue or dark grey business suit with a white shirt and tie or a black tuxedo, black bow tie, plain white tuxedo shirt, black socks and black dress shoes.

Those who wish to observe the exemplification will follow the same dress code as the candidates.

Dinner reservation forms are included with this correspondence. Please make copies for distribution to both Candidates and Sir Knights wishing to attend the Exemplification and Banquet.

If anyone writes a check for someone else, PLEASE make sure to note on the memo line who the payment is for. ALL checks must be payable to Garry Daly, Master.

Section 6: Enter your Membership Number from your Council 3rd Degree Membership Card. Check the box for *New Member*.

Section 7: Have your Council Financial Secretary complete the certification of *Member in Good Standing*.

Please return the completed Form 4 and Banquet Reservations to your Proposer or Council Captain; with a check for your Candidate's Fee made out to **Garry R Daly - Master**.

ELIGIBILITY FOR MEMBERSHIP

To be eligible for membership in the Fourth Degree, a Candidate must be:

- 1) Over 18 years of age.
- 2) A practical Catholic in union with the Holy See.
- 3) A current 3rd Degree Member in your Council.

DRESS

The “*Official Dress*” for Candidates for the 4th Degree Exemplification is either a black, dark blue or dark grey business suit with white shirt and tie, or a black tuxedo, black bow-tie, plain white tuxedo shirt, black socks, and black dress shoes.

Clergy may wear their clerical attire; and members of the armed forces, full time Police and Firefighter Officers may wear their respective dress uniforms.

Observers: Same as candidates, although those Sir Knights with the new uniform are allowed to wear the uniform for the events of the day.

LADIES ENTERTAINMENT

For the Ladies, there will be a program following their lunch at 12:15 PM (doors open at 11:30 AM). This will include fun, prizes, and refreshments. The price is \$24.00. Afternoon wear is suggested for the luncheon. The dress for the reception and banquet will be evening wear.

ADDITIONAL INFORMATION

DEPOSITS

All initiation fees are due with your application for membership in the 4th Degree. All costs for additional banquet dinners or ladies luncheon are due by **March 30, 2019!**

DEADLINES

To ensure that ALL applications are completed accurately, **the candidate’s application must be received, voted on, and approved by the Assembly before it is submitted to the Master of the 4th Degree.**

Once the Application has been voted by the Assembly, the Form 4, Banquet Reservation and payment (COMPLETE PACKET) will be mailed to the District Secretary by the Assembly.

Candidates mailing anything directly to the Master or District Secretary will have that mailing returned to them without being processed.

The Assembly you are joining must process your paperwork before it is submitted to the Master.

ALL applications for membership in the 4th Degree should be submitted to the District Secretary by **March 30, 2019**.

All Banquet Reservations must also be received by: **March 30, 2019**.
